The deadline for award applications for the Fall Conference was July 15, 2014. The Awards Committee will meet to review Award Nomination Applications immediately following today's Executive Board meeting.

COMMITTEE ON PROFESSIONAL AND EDUCATIONAL DEVELOPMENT (COPED) - Todd Webb

The COPED Committee members are Todd Webb, Chair, Ed Norris, Dr. Eliezer Bermudez, Stephanie Cain and Patty Nocek. By majority vote the Committee established a policy of non-eligibility to receive COPED scholarships. There must be a period of 3 years or more between the last scholarship received and application for another scholarship. If you received a scholarship within 4 or 5 years, you are still eligible but would be at the bottom of the list. After 5 years, you are eligible for full scholarship again.

Currently there is \$2,003.73 available for scholarships. At this time only 1 eligible scholarship has been received for Fall Conference registration. The NEHA CEU application has been sent for consideration. The IEHA Fall Conference is on the NEHA events webpage.

The 2015 IAFP AEC will be in Portland, Oregon – July 25 to 28.

There was discussion to allow a \$2,000 line item in the budget for 2015 for the IAFP delegate to offset conference costs. This is the same as the NEHA line item in the budget. Kelli Whiting moved that the IAFP line item be added to the 2015 budget, it was seconded by Reba Taylor-Hill and passed unanimously.
